

OVERVIEW

Every day, New Hampshire hospitals and health systems go above and beyond their mission of delivering high quality, affordable healthcare to their patients. This communications toolkit is designed to help our member hospitals highlight the collective story of how New Hampshire hospitals contribute to the overall health of the state, and to take action to ensure that community and state leaders understand and appreciate the local impact of hospitals beyond caring for the injured and sick. Your hospital's participation in this communications initiative will improve the visibility of the unique community health impact programs throughout the state and serve to greatly enhance statewide advocacy on behalf of New Hampshire hospitals.

This communications toolkit is for use with the recently released 2020 Statewide Community Benefit Report, as well as the 2021 NH Hospital Fact Sheet.

Highlights from the **2020 Statewide Community Benefits Report**, published by the Foundation for Healthier Communities (FHC) and its affiliated organization, the New Hampshire Hospital Association (NHHA), showed that [HOSPITAL NAME] provided:

The statewide community benefits report is published annually by the FHC and NHHA to demonstrate the impact of New Hampshire hospitals and health systems beyond the traditional hospital care setting. The 2020 report represents data collected fiscal year 2018 data from 24 New Hampshire hospitals as they reported to the IRS to quantify hospital contributions, such as unreimbursed costs, uncompensated care and other free, discounted and unique programs that are critical to the health of New Hampshire communities.

"New Hampshire hospitals and health systems are committed to their communities and to improving the health of New Hampshire residents and deliver care beyond the walls of the traditional health care setting," said NHHA President, Steve Ahnen. "This report truly demonstrates the value that our hospitals bring to their communities, not just in the hospital but through activities that address the unique health care needs across of their community."

[PROVIDE EXAMPLE OF HOSPITAL COMMUNITY BENEFITS PROGRAM]

Community benefits programs are designed to provide increased access to care and address population health inequalities for vulnerable patients. In order to be considered a community benefit, a program or service must respond to an identified community need and meet at least one of these criteria: improves access, enhances health, advanced medical or health knowledge or relieves or reduces the burden of government. By providing preventive health services and programs, New Hampshire hospitals and health systems are helping to reduce the need for more costly emergency treatment and acute care while also improving the health and well-being of entire populations.

Key Messages / Talking Points

New Hampshire hospitals and health systems provide essential benefits that improve the overall health and wellbeing of their communities. Hospitals are driving change by expanding care beyond the walls of the traditional healthcare setting to play a broader role in managing the health needs of patients and communities.

The most recent statewide community benefits report released by the New Hampshire Hospital Association and the Foundation for Healthy Communities, representing fiscal year 2018 data from 24 New Hampshire hospitals, demonstrates the following hospital contributions:

Community Benefit:

- Through their uncompensated care, health education, and community programs and services, New Hampshire hospitals invested more than **\$490 million** in community benefits in 2018 to improve the health and well-being of their communities.
- [HOSPITAL NAME] invested **[\$ TOTAL]** in community benefits in 2018 through its voluntary programs and services aimed at improving the health and well-being of [TOWN/COMMUNITY]
- [HOSPITAL NAME] provided **[\$ TOTAL]** in financial assistance in 2018, which includes unreimbursed Medicaid costs, the cost of care provided at a free or reduced rate for those who are unable to pay and costs of other government health programs. Statewide, New Hampshire hospitals combined provided more than **\$298 million** in financial assistance to access care in 2018.
- [HOSPITAL NAME] provided [\$ TOTAL] in other community benefits programs in 2018, such as
 [EXAMPLES OF COMMUNITY BENEFITS SERVICES]. Combined, New Hampshire hospitals serve their
 patients every year through community benefits such as free or low-cost immunizations, charitable
 contributions, family support services, health education and community building activities provided
 voluntarily at a cost of nearly \$193 million.
- New Hampshire hospitals experienced a loss of **\$582.1 million** in 2018 as a result of Medicare and Medicaid reimbursement shortfalls, or government reimbursements that are less than the actual cost of providing the care.
- [HOSPITAL NAME] had [\$ OF TOTAL UNCOMPENSATED CARE] in uncompensated care costs; a reduction in charity care and bad debt for hospitals means these funds can be reallocated to other important community programs and services.
- Community benefits include health services for vulnerable or underserved people; financial or inkind support of public health programs, such as management of chronic diseases like asthma and diabetes; donations of funds, property, or other resources that contribute to a community priority, such as obesity, substance abuse, or health care services for the homeless; health care cost containment activities, like free health education programs that can help people manage their conditions without the need for more costly services; and health screening and prevention services among others.

Key Messages / Talking Points

Social/Public Health Impact:

- As the healthcare delivery system changes to a model that focuses on population health, New Hampshire hospitals are expanding their community benefit strategies to address the social determinants of health to better meet the needs of their patients.
- New Hampshire hospitals work collaboratively with a variety of partners to assess the health of their community, identify the most pressing health needs, and develop community benefit implementation plans to address those needs.

Protecting Quality Patient Care:

- Carrying out the promise of the Blue and White H to deliver health, healing and hope, New Hampshire hospitals are dedicated to caring for their communities and ensuring access to quality, compassionate care.
- Since 2016, New Hampshire hospitals have **avoided 2,535 patient harm events** and achieved over **\$21.7 million in healthcare savings** under the *Partnership for Patients Initiative*.
- [HOSPITAL NAME] participates in the NH Health Care quality & Safety Commission, which is a critical resource for hospitals statewide that promotes accountability, cultures of safety and the sharing of best practices and prevent strategies.

Economic Impact:

- Hospitals are major drivers of economic activity; providing jobs, contributing to charitable causes and reducing overall community health costs.
- [More than/nearly] [**TOTAL # EMPLOYEES**] are employed by [HOSPITAL NAME] of the more than **73,000** people employed by New Hampshire hospitals statewide.
- Hospitals play an integral role in the state's economy, generating more than **\$5.6 billion** in total salaries and benefits that directly impact local business and community development.
- In 2018, [HOSPITAL NAME] gave **[\$ DONATION TOTAL]** through charitable and in-kind donations in support of community programs and services.
- In many communities, especially in New Hampshire's rural areas, hospitals and health systems are the largest employers, providing stability and economic benefits for their communities.
- New Hampshire hospitals play a vital role in the state's healthcare budget. As a result of the financial contributions our hospitals make, NH residents have access to healthcare services and expanded health insurance options which makes for a healthier New Hampshire.
- In 2020, New Hampshire hospitals paid **\$265.7 million** in provider taxes to the state, leveraging another **\$265.7 million** in federal matching funds for a total contribution of **\$531.4 million** to the state's healthcare budget [POST PROTECTING ACCESS TO CARE SLIDE]
- Since its inception in 1991, NH hospitals have paid **\$4.41 billion** in provider taxes through the Medicaid Enhancement Tax (MET) program.

Community Benefits






