Our Voices Were Heard

The NHHA works throughout the year on behalf of hospitals across the Granite State to help our members do their jobs of caring for the patients and communities who depend on them. Throughout 2023, the voice of the NHHA was strong, as shown by these highlights:

- The SFY 24/25 State Budget was one of the highest priorities for NHHA in 2023. The House and Senate passed the compromise budget bill (HB 1 and HB 2) on June 8, 2023, in an extraordinary way, on a voice vote in the House.
- The state budget included several important health care related provisions including another high priority item for NHHA related to reauthorization of Medicaid Expansion.
 With the assistance of a broad stakeholder group, Medicaid Expansion has been reauthorized for an additional seven years.
- Other important inclusions in the state budget targeted reimbursement increases for many Medicaid providers that are intended to assist in addressing barriers to discharge from hospitals, expansion of Medicaid coverage for mothers, funding for housing programs and many more.
- The Workplace Violence Prevention Commission was reorganized under the NH Department of Labor. Hospitals and other health care providers assigned designees and the Commission kicked off its first meeting in early December.
- NHHA's ongoing behavioral health litigation resulted in a final ruling by the federal court in the hospitals' favor. That ruling prompted the announcement of a joint resolution between the State of New Hampshire and hospitals to focus on solutions to ensure that patients who are subject to an involuntary emergency admission be accepted for admission to a designated receiving facility within six hours. An important outcome is the development of a Mission Zero Steering Committee which includes NHHA and hospital representation focused on improving access to behavioral health services throughout the continuum of care.
- NHHA continued to highlight the ongoing struggles with Anthem's policies and practices
 that have lead to unacceptably high levels of accounts receivable and the need to
 resolve those issues now.
- A number of priority bills were signed into law, including adding warrantless arrests for incidents that happen in a health care setting, improving insurance-based provider credentialing, streamlining professional licensing boards and Office of Professional Licensure and Certification statutes and removing burdensome Board of Pharmacy requirements on pharmacists.

Data Informed Decision-Making

Data has become increasingly important in identifying issues, measuring the effectiveness of strategies and gaining insight that enables people to take action. Analyzing data ultimately results in informed decision-making and problem-solving, and a better outcome for all.

Several new NHHA data tools took center stage in 2023:



- Made accessible to all members an interactive platform called the NH Hospital Utilization
 Dashboard that includes five years of hospital discharge data.
- Launched monthly data collection of "Barriers to Discharge" for all patients in NH
 hospitals who are medically cleared but remain in the hospital awaiting a final disposition
 for their next level of care.
- Published the latest Community Benefits Report in collaboration with the Foundation for Healthy Communities, highlighting the great community support that hospitals provide throughout the state.
- Published a number of reports and one-pagers on key issues facing hospitals to help inform legislators, the media and the public, including: Challenges Facing Hospitals in 2023, Barriers to Discharge, Report on Anthem's Performance, Economic Benefit of Hospitals, Impact of Medicaid Expansion and more.



Service to Others

The NHHA recognizes the importance of volunteer service to our local nonprofits. This year we lent a hand at the YMCA of Concord and the New Hampshire Coalition Against Domestic and Sexual Violence as part of the 2023 Granite United Way Day of Caring – Merrimack County. Our staff turnout for the event was great, with 15 participants undertaking gardening work and cleaning banners. Our staff also contributed to a local nonprofit, Family Promise, during the holiday season to support several well-deserving families.

A New Chapter

This year saw some familiar faces depart and some new ones join the team.

Vanessa Stafford, our Vice President of Communications, left to take on some new adventures earlier in the year. Year-end saw both Sally Reifsnyder, our executive assistant for seven years, and Paula Minnehan, our Senior VP, State Government Relations, who was with the organization for 22 years, retire. We wish them all well in 2024 and the years ahead.

Joining the team in the summer was Tammy Boucher, our new Director of Communications. Winter saw Jackie Derosia, Executive Assistant/Officer Manager, and Ben Bradley, Vice President, State Government Relations, come aboard.










Working Together Toward A Common Vision
