

Inside the Beltway: Health Policy and Politics in 2025

As the health care landscape continues to evolve in the wake of a pivotal election, hospital and health system leaders must stay ahead of rapidly shifting policy, political and regulatory developments. Rick Pollack will join us virtually from Washington, DC in a "fireside chat" with NHHA President Steve Ahnen to examine how decisions being made in the nation's capital are shaping the priorities of hospitals across the country. The adoption of the budget reconciliation bill, the One Big Beautiful Bill Act, will usher in the largest cut in Medicaid spending in history and have significant implications for hospitals and health systems as they continue to work to serve the patients and communities who depend on them to be there when they are needed most. And negotiations surrounding funding of the government will undoubtedly pose additional challenges for hospitals and health systems. In addition to Rick's up-to-theminute analysis, they will explore how state hospital associations are working closely with the AHA and hospital leaders across America to ensure lawmakers understand the implications of policy proposals on your ability to always be there, ready to care for your communities.

Accelerating Progress on Safety and Quality: The Essential Role of Leadership and Governance

The call for strong connections between safety and quality improvement and organizational leadership and governance continues to grow. Dr. Gandhi will speak to the importance of active hospital leader and trustee engagement signals to clinicians and administrators that patient safety is a core value for the organization.
